Sign the petition by Justice for Soleiman "We want to see charges laid against those responsible for Soleiman's death. Help us by calling for accountability and transparency." https://change.org/p/justice-for-soleiman-faqiri https://justiceforsoli.com "Soleiman Faqiri was a 30-year-old Canadian-Muslim man struggling with mental health who was killed while in custody at the Central East Correctional Centre in Lindsay, Ontario on December 15, 2016.

"According to a surveillance video and internal report, Soleiman died after guards at the provincial facility pepper-sprayed and beat him. As a result of the vicious beating, Soleiman sustained fifty bruises and a blow to the head. His hands were bound behind his back when he was being pepper sprayed. Soleiman was then forced into handcuffs and leg shackles and returned to a cell in solitary confinement, which the United Nations notes can constitute torture when prolonged and used against those suffering with mental health.

"Soleiman was one of five siblings and the family came to Canada from Afghanistan when he was a young boy. Soleiman's family describes him as a kind, gentle soul who meant the world to his friends and family. Even while he suffered from schizophrenia, he always had a warm smile and a kind word to share. Soleiman needed a bed and a doctor, instead he got fists and cuffs. "An initial police investigation exonerated any guards from wrongdoing and no charges were laid, even though thirty guards were in his cell. The Ontario provincial government is refusing to provide the family with access to the full investigative file.

"Now in 2019, after a year-long investigation by CBC's The Fifth Estate that has uncovered 1,500 pages of never-before-seen documents, his family are on a West Coast speaking tour to Vancouver and Victoria in order to build support for the demand that the government open a new investigation by an external police force and to seek justice for Soleiman"

Write to Immigrant Detainee by **End Immigration Detention Network**: send letters of support inside the prison walls to a detainee from Nigeria being held in Ontario who has spoken up against the immigration detention system and has consented to receiving mail: **Akin Akinsuyi**, Toronto East Detention Centre, 55 Civic Road, Scarborough, ON M1L 2K9

"Prisons are notorious for censoring mail, especially mail with perceived political or 'anti-social' content. There is no guarantee that messages will make it inside. However, prisoners say that receiving mail is an incredible way for them to feel supported by and connected to the outside world. So let's try! Keep messages simple, direct, and 'clean' (no cuss words)."

launch an investigation against the Wabash Valley Correctional Facility by Friends and family campaign to free political prisoner Khalfani Malik Khaldun khalfanikhaldun.wordpress.com Racial discrimination: Activist prisoners who exercise their rights to file grievances "are targeted, labeled as snitches, or our cells searched and trashed in retaliation". "San Francisco Bay View National Black Newspaper has been confiscated. This newspaper has been termed 'Black supremacy thought,' racist and security threat group material. Ignored is its celebrating and promoting love, empowerment and culture and encouraging economic rebuilding of the poor Black community." "On the flipside … White nationalist books and newspapers… are not labelled as 'White supremacist' or related to security threat groups. The White prisoners are allowed to possess these materials… This is an undeniable truth that fosters biases." Program discrimination: "facility staff in positions of power have and will prevent some of us from becoming participants"

Abuse of power and using positions to retaliate: "Examples of abuse of job position, harassment and unprofessional retaliation exist every day in Wabash Valley Correctional Facility."

Nepotism is perpetuated and promoted: "environment of Prejudice, and Staff Nepotism"

Targeting, harassment, unprofessional conduct and prejudice: "the Restricted Movement Housing Unit ... officers operate on a code of conduct that is not in compliance with any policy or law I know of."

Criminal behavior by staff, violations of code of ethics, conduct unbecoming of staff, fraternization: "These violations continue to persist under the watchful eyes of their superiors. The officers engage in selective games of fraternization with various prisoners, by providing information to them on negative gossip circulating about other prisoners. This is intentionally done to keep us divided as a prisoner class. Having us at odds with one another this way has proven to keep our eyes off the real violations that permeate this prison environment."

Abuses in the selection and use of administrative restrictive status housing units: "Many of us who are currently in the G-Housing Unit and on Restricted Movement Status are here unjustly, because the criteria don't apply to those of us who have good conduct records."

2018 Montreal New Year's Eve Noise Demo

"150 people gathered ... outside prisons in the Montreal area to set off fireworks, wish people in prison a Happy New Year, and show our opposition to prisons, borders, and the industries and governments that sustain them."

"Dozens of people stood in their cell windows waving and shouting back to us" "at Leclerc, a provincial prison for women ... we noticed lights flickering on and off in the windows of the prison!" "Federal Training Centre Minimum ... a few people had come out of the buildings to stand in the yard despite the cold and they waved and yelled to us from across the fence" "MCs reminded us of the hunger strike against the government's 'alternatives to detention' plan that imprisoned migrants in Ontario carried out in September of this year. This plan includes introducing an electronic monitoring program and contracting the John Howard Society and the Salvation Army to create 'parole-type' programs for migrants. We think it's all a way to control and monitor more and more migrants who come to this country, who are often fleeing situations of violence that Canadian imperialism helped create. ...

Prison volunteers face new, longer security checks January 9 *Globe and Mail* Lisa Steacy "A year ago, the Correctional Service of Canada issued a directive requiring volunteers to obtain 'reliability status.' In order to enter a prison, volunteers are now subject to the same screening and scrutiny as staff. This includes fingerprinting and a credit check, in addition to the prior requirements of a criminal record check, application and orientation class."

"Joint Effort ... has been trying to either get an exception to the requirement for reliability status or to get the directive reversed. So far, they have been unsuccessful and they have stopped sending volunteers."



"Joint Effort is a women in prison abolitionist group involved in solidarity work with women prisoners in the Lower Mainland.

"Joint Effort started as a sub committee of the BC Federation of Women and has been volunteering at the women's prison since 1980. The group consists of women who work to create contacts between women in prison and various community organizations outside the prison. "On the 'inside' our work consists of organizing discussion groups, various workshops and music, theatre and sports events. We work with the Inmate's Committee and the Native Sisterhood to support their activities in any way that we can. In our weekly visits we try to create a space where women from 'inside' and 'outside' can communicate around issues of mutual interest, where respect and confidentiality are practiced and where a woman can speak her mind and be supported.

"On the 'outside', Joint Effort is involved in providing public information about the situation of women in prison as well as lobbying the government on various issues.

"Joint Effort is an independent group that is not associated with the prison or the church. We are unpaid workers and the group does not receive any government or institutional funding.

Stop the Laval migrant prison "In 2016 the federal government announced the construction of a new migrant detention center in Laval.

"This prison, which is anticipated to hold up to 158 migrants, is intended to be built on Correctional Service of Canada grounds, right beside Leclerc prison, and is slated to open in 2021. While the Liberal government is attempting to spin this project as a more humane way to detain migrants, we call it what it is — a prison, and know that this is simply prettier window dressing on a violent system of imprisonment and deportation, one that keeps people locked in cages while tearing apart families and communities. We want a world without prisons or colonial borders, a world where people, not states, can decide how they can move and where they can stay. Stopping the construction of the Laval Immigration Detention Centre is one step in the struggle to tear down migrant prisons everywhere.
